The Shively Code Enforcement Team works to support a safe, inviting, and healthy environment for residents, businesses, and visitors.

## **HOW DOES IT WORK?**

The Shively Municipal Code represents the City of Shively's laws adopted by the Shively City Council. Code Enforcement is responsible for enforcing the parts of the Code that relate to conditions of private property (both residential and commercial).

Our Code Enforcement Officers respond to complaints from citizens regarding conditions on private property and encourage compliance with the Shively Municipal Code. If a violation is found, a case is opened. Our team works with the property owners to reach compliance.

Junk vehicles, uncontained garbage and debris, illegal signs, roosters, construction without permits, and overgrowth are some of the common complaints received and investigated by Code Enforcement.

Compliance is typically reached through promoting public awareness, communication, and collaboration.

We encourage community members to reach out to our Code Enforcement Team with any concerns they may have related to private property code compliance.
