PUBLIC COMMENTS:

Antoine Lovelace, Louisville Shively Titans, I learned we are unable to practice on the field this year. I have kept in contact with the board members and Keisha Dorsey and I thought everything was ok. I brought parents by in the fall to keep in touch. I have sent out donation letters speaking about Shively. It was shocking. We changed our name so we could be sponsored by the Tennessee Titans, we were the Cougars. We have the walk it like we talk it program to clean up the neighborhoods. I have talked to members of the board to be involved in the programs they have. We have been here for 15 years, I thought we had the park.

Troy Burks, when I came to ask for the field there was no one using the field. They merged with the Packers and practiced at Algonquin. As far as 15 years, he has not been with the same group practicing in this park for 15 years, there has been several teams and people here. I communicated with Speedy and Nicole at Holy Cross, not Wendell. I had asked Nicole if we could practice with the lights because she had access to the lights. I asked on a regular basis to merge so there is one team in Shively when Holy Cross folded and we could not get it off the ground. The Seminoles started here 9 years ago. I did not come to be deceitful, I thought they were not coming back because their kids were spread out to other teams.

Chester Marr, 2106 Crums Lane, I sent a letter to the Kentucky State Insurance Department with my declaration page. Kentucky State Insurance Department sent a letter to my insurance company, Shelter Insurance. My insurance company called me and said Kentucky allows the insurance company to charge a fee for collecting insurance taxes. There are two options for charging the fee; two percent of the insurance premium or fifteen

percent of the total taxes collected off the policy. The insurance company is required to choose the option that is the lesser of the two. My insurance policy did not list the fee, they listed it as total taxes.
