We have no plans to sell alcohol, it is just a place to hang out and work on motorcycles, members may bring their own alcohol. I am speaking with Julie at State ABC to learn the regulations. Prior location of the club was near Market Street and Louisville, they are relocating because of size. There are 16 members that pay dues, no employees, no regular hours, we may be there one Saturday out of a 6 month time frame.

Robert and Irene Brightwell, 2411 Farnsley Road, I have a 4-foot fence installed in my front yard. I did this for safety concerns, my neighbors child runs across my driveway and I am scared I would hit a child. I want the council to approve the fence because this is a real safety concern of ours.

Dean Nevitt, 1859 Farnsley Road, I am requesting the amount of money the city collects from residents and business in property tax.

Capprico Skates, Bristol Bluffs Avenue, I am sorry for damaging your property. I am sorry for hurting the feelings of my family. I am responsible for the actions I have made.
