

**CITY OF SHIVELY  
ORDINANCE NO. 9, SERIES 2021**

**AN ORDINANCE ESTABLISHING AND DEDICATING THE WADE-BRADEN  
PEACE PARK IN THE CITY OF SHIVELY, LOCATED AT 2902 HARTLAGE  
COURT, 2906 HARTLAGE COURT, 3001 CRUMS LANE AND LOT 4 HARTLAGE  
COURT, SHIVELY, KENTUCKY**

**WHEREAS** the City of Shively purchased real property located in the City of Shively located at 2902 Hartlage Court, 2906 Hartlage Court, 3001 Crums Lane and Lot 4 Hartlage Court, and

**WHEREAS** the City of Shively authorized and approved the purchase of said properties as set forth in City of Shively Ordinance No. 8, Series 2019, and

**WHEREAS** KRS 97.010 provides that the acquisition, development, maintenance and operation of parks, playgrounds and recreation centers, which may include but is not limited to zoos and museums, is a proper municipal purpose for all cities and counties. The legislative body of any city or the fiscal court of any county may dedicate for use as parks, playgrounds and recreation centers any lands or buildings owned or leased by the city or county and not devoted to an inconsistent public use and may acquire real property for such purpose by purchases, lease, condemnation or otherwise, at any place reasonably accessible to the inhabitants of the city or county and either within or without the boundaries of the city or the county, and

**WHEREAS** KRS 97.020 further provides that the legislative body of any city or the fiscal court of any county may establish a park, playground and recreation system and may vest the power to provide, maintain and equip parks, playgrounds and recreation centers and the buildings thereon, and

**WHEREAS** Pursuant to KRS 97.530, the City of Shively intends to establish and dedicate a public park in the name of the Wade-Braden Peace Park in honor of the Wade and Braden families, and

**WHEREAS** the Mayor and the City Council have determined that it is in the best interest of the City of Shively to establish and dedicate the Wade-Braden Peace Park for the people of the City of Shively, now therefore:

**BE IT ORDAINED BY THE CITY OF SHIVELY:**

**SECTION 1.** The City Council of the City of Shively hereby establishes the Wade-Braden Peace Park and dedicates its establishment in honor of the Wade and Braden families and to the people of the City of Shively.

**SECTION 2.** This ordinance shall take effect from and after passage and approval as required by law.
