

**CITY OF SHIVELY
ORDINANCE NO. 1, SERIES 2020**

**AN ORDINANCE LEVYING TAXES FOR THE CITY OF SHIVELY,
KENTUCKY FOR THE FISCAL YEAR 2020-2021**

BE IT ORDAINED BY THE CITY OF SHIVELY:

SECTION 1.

That the following ad valorem tax for the fiscal year 2020-2021 is levied by the City of Shively, Kentucky on all lands and improvements in the City of Shively, Kentucky held or owned by every person, firm, company, association or corporation in his, her, their or its own right or as fiduciary, guardian or agent, subject to municipal taxation and under the laws of the Commonwealth of Kentucky, including all property and franchises here-to-fore or hereafter assessed by the City Assessor and in the case where such action is required by the law by the state railroad commission, or the Revenue Cabinet of the Commonwealth of Kentucky for taxation by the City of Shively, Kentucky, in and for said year 2020 in the amount of \$33.9 cents on each one (1) hundred dollars of assessed value, but not to include any property exempt by law from such taxation.

SECTION 2.

That the following ad valorem tax for the fiscal year 2020-2021 is levied by the City of Shively, Kentucky on all personal property in the City of Shively, Kentucky held or owned by every person, firm, company, association or corporation in his, her, their or its own right or as fiduciary, guardian or agent, subject to municipal taxation and under the laws of the Commonwealth of Kentucky, including all property and franchises here-to-fore or hereafter assessed by the Revenue Cabinet of the Commonwealth of Kentucky for taxation by the City of Shively, Kentucky, in and for said year 2020 in the amount of \$36.3 cents on each one (1) hundred dollars of assessed value, but not to include any property exempt by law from such taxation, PROVIDED HOWEVER, that the ad valorem personal property tax as it applies to motor vehicles shall be at the rate authorized by KRS 132.487.

SECTION 3.

Said taxes are due and payable as soon as the tax bills come into the hands of the collector in the year assessed. From and after October 1, in the year assessed and thereafter, a penalty in the amount of 10% (ten percent) per annum of the face amount of the bill shall be imposed plus interest from October 1, in the year assessed and thereafter at the rate of 6% (six percent) per annum, except that on property assessed by the Commonwealth of Kentucky.

SECTION 4.

This ordinance shall take effect from and after its passage and publication as required by law.
