Ordinance No. 4, 1995 – AN ORDINANCE DESIGNATING AS UNLAWFUL AND A PUBLIC NUISANCE AND AN ENVIRONMENTAL NUISANCE THE ACCUMULATION OF LEAVES, BRANCHES, TIMBER, BUSH, WEEDS, FILTH, TRASH, RUBBISH OR OTHER SIMILAR ORGANIC OR NON-ORGANIC MATERIALS WITHIN THE CITY OF SHIVELY, KENTUCKY, AND PROVIDING FOR NOTIFICATION TO THE OWNER AND/OR OCCUPANT OF THE SITE THEREOF TO REMEDY SAID PUBLIC AND/OR ENVIRONMENTAL NUISANCE WITHIN FIVE (5) DAYS AND FURTHER PROVIDING FOR ABATEMENT OF SAID PUBLIC AND/OR ENVIRONMENTAL NUISANCE, AND THE ACCRUAL OF LIENS FOR THE COST OF SUCH ABATEMENT IN FAVOR OF THE CITY OF SHIVELY, KENTUCKY AFTER FAILURE TO COMPLY WITH NOTIFICATION AND FURTHER PROVIDING FOR FINE AND JAIL SENTENCES FOR VIOLATION THEREOF

Ordinance No. 10, 2005 – AN ORDINANCE PROHIBITING PLAYING AND/OR ATHLETIC GAMES OF ANY KIND INCLUDING BUT NOT LIMITED TO THE PLACEMENT OR USE OF PORTABLE BASKETBALL GOALS ON PUBLIC STREETS
