# AN ORDINANCE AMENDING SHIVELY CODIFIED ORDINANCE CHAPTER 32, SECTION 32.21, (ORD. NO. 1, SERIES 1985) SETTING THE DAY OF THE REGULAR MEETING WHEN IT FALLS ON A LEGAL HOLIDAY

<u>WHEREAS</u>, presently, if the City of Shively regular Shively City Council Meetings and Shively Code Enforcement Board meetings fall on a legal holiday, the meetings are held the Tuesday following the regular meeting, and

<u>WHEREAS</u>, the Shively City Council has determined that in the best interest of the city, if a regular Shively City Council meeting and Shively Code Enforcement Board meeting fall on a legal holiday, the regular meeting shall be held on the next Monday that follows the legal holiday, now therefore:

#### **BE IT ORDAINED BY THE CITY OF SHIVELY:**

- SECTION 1. The regular meetings of the City Council of the City of Shively, City Caucus and Code Enforcement Board shall be held in the Newman Memorial Building, 3920 Dixie Highway, Shively, Kentucky.
- **SECTION 2.** Caucus meetings and regular meetings of the City Council shall be held monthly according to the following specific schedule:

1<sup>st</sup> Monday: Caucus, 6:30 p.m., regular meeting, 6:45 p.m., Code Enforcement Board, 5:30 p.m.

3<sup>rd</sup> Monday: Caucus, 6:30 p.m., regular meeting, 6:45 p.m., Code Enforcement Board, 5:30 p.m.

**SECTION 3.** If a legal holiday occurs on the day of the meeting, the regular meeting of the said City Council and Code Enforcement Board shall be held the following Monday [Tuesday] at the time listed above. Legal holidays are New Year's Day, Dr. Martin Luther King's Birthday, Memorial Day, Juneteenth, July 4<sup>th</sup>, Labor Day and Christmas Eve or Christmas Day.

**SECTION 4.** This ordinance shall take effect from and after passage, approval and publication as required by law.
