CITY OF SHIVELY ORDINANCE NO. 7, SERIES 2025

AN ORDINANCE AMENDING SHIVELY CODIFIED ORDINANCES, TITLE XV LAND USAGE, RELATING TO THE REGULATION OF TRAMPOLINES IN THE CITY OF SHIVELY

<u>WHEREAS</u> the City of Shively has determined that it is necessary to regulate the placement of trampolines within the city, now therefore:

BE IT ORDAINED BY THE CITY OF SHIVELY:

SECTION 1. In City of Shively codified ordinances, Title XV Land Usage, a new Chapter 159 entitled "Trampolines", is hereby created and adopted as follows:

§159.01 DEFINITIONS.

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning:

<u>"TRAMPOLINE."</u> A sheet of strong, taut canvas, or other similar material attached with springs to a metal frame and used for acrobatic tumbling or other similar activities. By definition, trampoline shall also include the in-ground varieties of trampolines.

§159.02 COMPLIANCE WITH PROVISIONS.

Every private residential trampoline shall comply with all applicable provisions of this chapter and with the provisions of the building and health ordinances and codes of the city.

§159.03 GENERAL REGULATION OF TRAMPOLINES - LOCATION

- (A) <u>Trampolines shall not be permitted in the front yard or side yard between</u> dwellings.
- (B) No trampoline shall be located under an electric line, telephone line or any other utility line.

§ 159.99 PENALTY.

(A) Violation of this chapter shall constitute a criminal violation for which a citation may issue returnable to District Court with a fine to be assessed for each violation consistent with subsection (B) of this section, or at the option of the city, and in addition to the foregoing, a violation shall constitute a civil offense and shall be enforced pursuant to the provisions of Chapter 41.

- (B) Anyone violating this chapter shall be guilty of a misdemeanor and fined not more than five hundred dollars (\$500.00) or imprisoned for not more than thirty (30) days, or both.
- (C) The civil penalty for violating this chapter shall be not less than one hundred dollars (\$100.00) nor more than one thousand dollars (\$1,000.00).

 Each day's violation shall constitute a separate offense. This chapter shall be subject to enforcement by the Code Enforcement Board of the city.

SECTION 2. Severability. If any provision of this chapter as now or later amended or its application to any person or circumstance is held invalid, the invalidity does not affect the other provisions that can be given effect without the invalid provision or application.

SECTION 3. This ordinance shall take effect upon its adoption by the Shively City Council and publication as required by law.
