

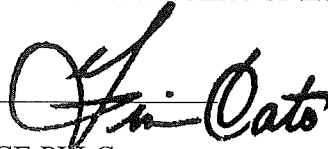

(AMENDED ORDINANCE. NO. 8, SERIES 2016) PROVIDING FOR THE  
ENFORCEMENT OF CERTAIN ORDINANCES BY THE SHIVELY CODE  
ENFORCEMENT BOARD AND FURTHER PROVIDING FOR CHANGES IN FINES  
TO BE ENFORCED BY THE CODE ENFORCEMENT BOARD FOR THE CITY OF  
SHIVELY**

I hereby certify that the foregoing ordinance provides for an amendment to the assessment of civil penalties for the violation of certain ordinances by the City of Shively Code Enforcement Board pursuant to the authority of KRS 65.8801 to 65.8839.

This ordinance specifically provides that the civil penalties to be assessed for ordinance violations in certain sections of the Shively Codified Ordinances shall be determined by the provisions of Ordinance No. 12, Series 2025 providing for changes in the schedule of fines to be enforced by the Shively Code Enforcement Board. These sections include, among others, abandoned and junked vehicles, nuisances, business and occupational license fees and regulations, adult entertainment license fees and regulations and unsafe and unfit structures. The civil penalty for the violation of any ordinance hereinafter cited for which no civil penalty is provided in Ordinance No. 12, Series 2025 shall not be less than \$250.00 nor more than \$1000.00. The civil penalties provided for in Ordinance No. 12, Series 2025 and in this ordinance shall be deemed to supersede the amount of any civil penalties specifically mention in the ordinance hereinafter set out.

**WHEREAS**, it is the intent of the KRS 65.8839 to protect, promote, and improve the health, safety and welfare of the citizens residing within the City by authorizing the City of Shively Code Enforcement Board with the authority to issue remedial orders and impose fines in order to provide an equitable, expeditious, effective and inexpensive method of ensuring compliance with the ordinance in force within the City, and,

**WHEREAS**, it is the desire of the City Council, and in the best interest of the City of Shively, Kentucky, to utilize the authority granted in KRS 65.8801 to 65.8839 to amend fines to be enforced by the City of Shively Code Enforcement Board to ensure compliance with the ordinance in force within the City, and,

**WHEREAS**, Shively Codified Ord. Sec. 41 (Ord. No. 8, Series 2016) is hereby amended to reflect the new fines for certain ordinances to be enforced by the Code Enforcement Board for the City of Shively. The specific sections amended are herewith set out in full.

**NOW THEREFORE BE IT ORDAINED BY THE CITY OF SHIVELY:**

**SECTION 1.** The following sections of the Code of Ordinances of the City of Shively, may be enforced through the assessment of civil violations within the meaning and under the authority of KRS 65.8801, et seq. The amount of civil penalties to be assessed shall be determined by the provisions of Ordinance No. 12, [7] [2016] Series 2025 [~~2016~~], an ordinance amending Shively codified ordinance, Chapter 41 (Ord. No. 7 [8], Series 2016 [1998]) providing for changes in fines and fees to be enforced by the code enforcement board for the City of Shively. The civil penalty for the violation of any ordinance hereinafter cited for which no civil penalty is provided in Ordinance No. 12 [7], 2025 [2016] shall not be less than two hundred fifty (\$250.00) [~~one hundred (\$100.00)~~] dollars nor more than one thousand (\$1,000.00). Each day's violation shall constitute separate offense. Nothing in this ordinance or Ordinance No. 12 [7], Series 2025 [2016] shall be interpreted to repeal or invalidate criminal prosecution and penalties specifically provided for in the ordinances hereinafter set out. The civil penalties provided for in Ordinance No. 12 [7], Series 2025 [2016] and in this ordinance shall be deemed to supersede the amount of any civil penalties specifically mentioned in the ordinances hereinafter set out.

**SECTION 2.** The following sections of the Code of Ordinances of the City of Shively shall be subject to enforcement by the Code Enforcement Board of the City of Shively pursuant to the authority of KRS 65.8801, et seq. and Shively Ordinance No. 12 [7], Series 2025 [2016]:
