ORDINANCE NO. 14, SERIES 2025 - CERTIFIED SUMMARY AN ORDINANCE AMENDING SECTION 1.2.2 AND CREATING SECTIONS 4.3.12 AND 4.4.12 OF THE SHIVELY LAND DEVELOPMENT CODE ("LDC") REGARDING SMOKING RETAIL STORES WITHIN THE CITY OF SHIVELY (AS AMENDED)

Ms. Gibson, will existing smoke shops have to follow this law, the new business hours.

Finn Cato, city attorney, this will take effect January 15, 2026, after that any new business will have to follow our land development code. Businesses that exist now do not have to follow this. If you are a new smoking retail establishment, you can't locate within 1,000 feet of a non-conforming existing smoke shop.




NEW BUSINESS:
